Dear User,

Due to changes concerning the privacy protection, we would like to recall the goals and principles on which we process your personal data

WHO IS THE ADMINISTRATOR OF YOUR PERSONAL DATA?

The administrator of your data is Powair sp. z o.o. with its registered office in Osielsko at ul. Centralna 2U (hereinafter referred to as "Powair").

WHERE DID WE GET YOUR DATA?

We could have send us your data:

- · when setting up an account in our company's online store;
- in connection with transactions made in our store at Allegro;
- when establishing trade cooperation;
- · when subscribing to the newsletter.

WHY ARE WE PROCESSING YOUR DATA?

We process them because it is necessary for the implementation of contracts concluded with you, including:

- enabling the provision of electronic services, performing the contracts and transactions in our stores
- setting up and managing your account or accounts, as well as providing your account support, transactions and troubleshooting technical problems;
- handling complaints;
- handling payment services;
- contacting you, including for purposes related to the provision of services.

In addition, the law requires us to process your data for tax and accounting purposes. We also process your personal data for purposes related to permitted marketing activities, through available communication channels, in particular and with your consent – by e-mail and telephone. You can withdraw your consent to the processing of personal data at any time in the same way as you have expressed it. We will keep processing your personal information until you withdraw your consen

DO YOU NEED TO PROVIDE US WITH YOUR PERSONAL DETAILS?

We may require the following personal data from persons or companies undertaking business cooperation with us to be able to enter into and execute the contract: name, email address, login, password, telephone and address information and, if applicable, company data. If for some reason we do not receive this personal data, unfortunately we will not be able to enter into a contract, and as a consequence the contractor will not be able to use our services. What are your rights to Powair concerning the processed data? We guarantee fulfillment of all your rights under the General Data Protection Regulation, i.e. the right to access, correct and delete your data, limit their processing, the right to transfer them, not be subject to automated decision making, including profiling, and the right to object to the processing your personal data.

IN WHAT SITUATIONS CAN YOU OPPOSE THE PROCESSING OF YOUR DATA?

You have the right to object to the processing of your personal data when:

- the processing of your personal data is based on a legitimate interest or for statistical purposes, and the opposition is justified by the particular situation in which you have found yourself,
- Your personal data is processed for direct marketing purposes, including profiling for this purpose.

WHO DO WE SHARE YOUR PERSONAL INFORMATION WITH?

Your personal data will be disclosed to the necessary extent to Powair subcontractors, e.g. service providers and information systems, courier companies etc.

HOW LONG DO WE KEEP YOUR PERSONAL DATA?

We store your personal data for the duration of the contract concluded with you as well as after its completion, for the purposes of: • pursuing claims in connection with the performance of the contract, • performance of obligations resulting from legal regulations, including in particular tax and accounting, • preventing abuse and fraud. We store your personal data for marketing purposes for the duration of the contract or until you object to such processing, whichever occurs first. Your personal data will be processed in the IT environment, they may also be temporarily stored and processed in order to ensure the security and correct functioning of IT systems.

You always have the right to access, rectify, erase or transfer your personal data or restrict its processing, the right to object to the processing of your data or to lodge a complaint with the supervisory authority (President of the Personal Data Protection Office, PUODO), and, where you data is processed based on your consent, the right to withdraw this consent at any time.
